OUTREACH PARTNER TRAINING: AS AN EDUCATION-FOCUSED ORGANIZATION, THE INTERNATIONAL WOLF CENTER TEACHES ABOUT WOLVES IN MANY WAYS. THE WOLVES AT OUR DOOR PROGRAM TAUGHT K-12 CLASSROOMS THROUGHOUT THE STATE OF MINNESOTA, SCHOOLS RECEIVED 90 PROGRAMS AND REACHED OVER 2,180 STUDENTS. A WOLF EXPERT AT THE CENTER BASED OUT OF THE MINNEAPOLIS ADMINISTRATIVE OFFICE TAUGHT THE PROGRAMS. OUTREACH PROGRAMS HAD TO BE CANCELLED FROM MARCH - DECEMBER DUE TO COVID-19 RESTRICTIONS.
